Fixtures Report Jan 19th 2016

Inter Counties October 15th/16th 2016

The hotel is booked, the coach is booked, as are 4 lanes at Loughborough Pool for the training/team building session on the Saturday.

I have managed to get a reduction on the room costs. So this year:

Hotel:

£65 Bed & Express Breakfast per room per night inc breakfast £12.00 per person for the 2 course Buffet Dinner £8.00 per person Packed Lunch (Sandwich, Water, Fruit, Crisps)

23 (rooms) x £65 = £1495 38 people x £12 = £456

33 packed lunches (swimmers and staff on Sunday) x £8 = £264

Hotel & food = £2215 Coach hire = £1095

Pool: 4 lanes, 2 hours at Loughborough pool: £187 TOTAL: £3497 (£413 above last year's costs)

I assume we will be eligible for £1000 reimbursement from the ASA again this time.

County Development Proposals:

I have had a further meeting with Kyle and, in turn, Kyle has consulted with other coaches in the County. A summary of his proposals are as follows:

1. Provide a training/bonding session for swimmers chosen for the County Squad. The event being the Inter Counties Sheffield, October 15/16th 2016

Loughborough booked 15th Oct 2016 2-4pm – 4 lanes. Cost: £187 inc VAT

2. Provide 2 x 2 hour long course sessions in July for those going to Summer Champs/English Champs. Open to all clubs for their qualifiers. The main remit is to allow swimmers to continue working with the home coach, each club having lane space to use for their own programme.

Examples of costs:

Bath can offer 8 lanes for 2 hours: £397.39

x 2 sessions = £794.78

Guildford - 8 lanes for 2 hours: £432 inc VAT

X 2 sessions = £864

Aldershot - 8 lanes for 2 hours: £496 inc VAT

X 2 sessions = £992

It could be that we can lessen the number of lanes, depending on the uptake of the offer.

I am trying to locate a pool that provides best location for all of ONB – unfortunately, High Wycombe has constraints on its hiring out to other organisations.

3. Provide County Development days for swimmers at County Level, aspiring to Regionals. These are based on similar camps run by the SER.

The 2 target groups are 11/12 years and 13/14 years. County times need to have been achieved in the previous Championships and swimmers must not have been selected for any other talent camps (selection policy/criteria yet to be formalised)

Following the NAG's the Synchro Swimming Management Group was disbanded and asked to cease all activities by the ASA.

Since then Maria Ramos has been instated by the ASA as Chair of a Synchronised Swimming Group in order to take forward a new strategy for Synchro based on a submission that was commissioned last summer. Since early January some members of the former management group have been asked to continue with plans in order for events & courses to take place.

At present there is no current Synchro Group but there is to be a meeting on 7th February in Loughborough to take things forward. I will be attending the meeting and will report back in March.
